INTRODUCTION

The records contain administrative, financial, and membership records for the Kansas City Federation of Musicians, Local 34-627, and its predecessor organizations, the all-white Kansas City Musicians Association, Local 34, and the all-black Musicians' Protective Union, Local 627.

DONOR INFORMATION

The records were received as a gift from Tony Salazar on 9/26/1985 (Accession No. KA0309). An addition was received from the Kansas City Federation of Musicians Local 34-627 on 9/15/2003 (Accession No. KA1247).

INSTITUTIONAL SKETCH

The Kansas City Musicians' Association, Local 34, American Federation of Musicians (A.F. of M), was chartered in February 1897. A separate local for black musicians – Musicians' Protective Union, Local 627, A. F. of M. – was chartered on March 2, 1917.

With passage of the Civil Rights Act of July 2, 1964, labor unions were forced to comply with the statue prohibiting discrimination in membership or employment based on race, color, religion, sex or national origin. As a result, the two locals merged on April 1, 1970 to form the now existing Kansas City Federation of Musicians, Local 34-627, A. F. of M.

SCOPE AND CONTENT NOTE

The records consist of administrative, financial, and membership records for the Kansas City Federation of Musicians, Local 34-627, and its predecessor organizations,

the all-white Kansas City Musicians Association, Local 34, and the all-black Musicians' Protective Union, Local 627. The records are arranged into the following six series:

Local 34 Records

This series consists of administrative, financial, and membership records. Administrative records include board of directors' minutes, membership minutes, and meeting minutes for Local 34 and its predecessor, Local 20. Administrative records also include general correspondence, subject correspondence, and photographs. Financial records include reports, payrolls, bills, invoices, and receipts. Membership records include member applications, ledger sheets, and records of dues. The series is arranged by record type: administrative, financial, and membership. Oversize materials have been withdrawn to Box 41. Seven rolls of microfilm containing the membership ledger sheets are available for viewing at the research center.

Local 627 Records

This series consists of administrative, financial, and membership records. Administrative records include board of directors' minutes, membership minutes, contracts, work dues, charges, claims, and cases, and project and program documents. Financial records include reports, tax forms, pension plans, expenses, financial correspondence, and receipts. Membership records include member applications, death records, membership reports, resignations, and membership balance sheets. The series is arranged by record type: administrative, financial, and membership.

Local 34-627 Records

This series consists of administrative and membership records and materials documenting the relationship between Local 34-627 and the Kansas City Philharmonic Orchestra. Administrative records include Local 34 and Local 627 merger correspondence and related materials, contracts, agreements, and wage bond receipts. Membership records include member applications, membership ledgers, and registers of dues. The series also contains documents concerning the relationship between Local 34-627 and the Kansas City Philharmonic Orchestra. These documents include contracts and agreements between Local 34-627 and the Kansas City Philharmonic Association; orchestra rosters and conductor evaluation sheets; grievances and legal testimony; annual program books and concert programs; and assorted newsletters and newspaper clippings related to the Kansas City Philharmonic Orchestra. The series is arranged by record type: administrative, membership, and materials related to the Kansas City Philharmonic Orchestra. Oversize materials have been withdrawn to Box 41 and Box 42.

Photographs

This series consists of photographs of conventions, musical groups, and musicians. The series is arranged alphabetically by subject. Oversize photographs have been withdrawn to Box 42.

Artifacts

This series consists of convention badges and print blocks. The majority of the convention badges are associated with the annual conventions of the American

Federation of Musicians, covering the period 1883 through 1907. The print blocks show unidentified musicians.

Audio

This series consists of three audio cassettes recording the final merger meeting between Local 34 and Local 627 in April 1970. Tapes one and two have been digitized; contact the research center for additional information.
