Introduction

Papers of Roseann Bentley, who served on the Springfield School Board, the Missouri State Board of Education, the National School Boards Association, the National Association of State Boards of Education, the Missouri State Senate, and as Greene County Commissioner.

She served on the various boards of education from 1974-1992, becoming president of both the Missouri Board of Education and the National Association of School Boards. Around 1994, she began campaigning for the Missouri State Senate and was elected to represent Missouri's 30th District from 1995-2003. By 2004, she was elected to serve as Greene County Commissioner and held that position until 2016.
