Historical Note:

Governor Lloyd C. Stark created the Missouri Council of Defense by executive order on January 17, 1941. House Bill No. 540, which authorized the governor to establish a State Council of Defense in times of national and state emergency or public need, was approved by Governor Forrest C. Donnell on July 2, 1941. The function of the council was to assist national defense in the coordination of state and local activities. The organization dissolved after the end of World War II.
