Historical Note:

Israel A. Smith was born at Plano, Illinois. He moved to Lamoni, Iowa, in 1881, and attended Graceland College in Lamoni for two years. Smith served in various civic offices and as a member of the 34th General Assembly of Iowa in 1912-1913. He was admitted to the Iowa Bar in 1912 and the Missouri Bar in 1913. Smith practiced law in Independence, Missouri from 1913-1938 when he became a member of the Presidency of Reorganized Church of Jesus Christ of the Latter-Day Saints.
