Historical Note:

The first history course offered at the University of Missouri was taught by President Lathrop in 1843. In 1894, President Jesse appointed Professor Hicks as the first chairman of history and

political economy, and Isidor Loeb became chairman of the department in 1899. Since 1902 history has been an independent department.
