Historical Note:

Xenophon Caverno was born in Waukesha, Wisconsin, on December 26, 1865. He graduated from the University of Wisconsin in 1890 with a degree in Mechanical Engineering. He owned and operated a farm of 1844 acres located three miles from Canalou, Missouri, developed from original timber in 1907. He died on September 13, 1941.
