Historical Note:

The Chariton County Exchange Bank was formed in Brunswick, Missouri, in March of 1877, one of the oldest businesses in that community. Stark Mauzey was the first president. The bank opened with \$50,000 in capital stock. In October of 1967 the bank was purchased by Commerce Bancshares, Inc., of Kansas City. J. J. McKinny was president of the bank at the time of its purchase.
