Thomas J. Payne and R.P. Williams purchased the Fayette Bank in Fayette, Missouri in 1878 and in 1884, changed the name to Payne and Williams Bank. In 1907, the name was changed to Fayette Bank. The bank closed in 1938, amidst the Great Depression.
