Abstract: The papers contain a deed of trust between Frederick Hamilton and B.F. Sharp and Beston Callahan, indenturing three enslaved people as security for notes, along with a bill of sale for enslaved people.

Biographical Note:

Frederick A. Hamilton was married to Margaret J. Sharp, whose father and brother were both named Benjamin Sharp. Margaret Sharp's sister, Hannah, was married to Beston Callahan. Hamilton was a newspaper owner who published the *Columbia Patriot* from December 1835 to December 1842.

Hamilton was also an enslaver who indentured Maria/Mariah and her daughter Mary Eliza, and William to B.F. Sharp and Beston Callahan. He later sold Maria/Mariah and William to Benjamin Sharp.

Frederick Hamilton died on July 18, 1845, and is buried in Montgomery County, Missouri.

Arrangement:

The collection has been arranged chronologically.

Scope and Content Note:

The papers include a deed of trust between Frederick Hamilton and B.F. Sharp and Beston Callahan, indenturing Maria/Mariah, Mary Eliza, and William as security for notes. Also included is a bill of sale for Maria/Mariah and William to Benjamin Sharp.
