Garrard and Elizabeth Mills Banks immigrated to Marion County from Kentucky with their families in October 1830. Born in 1826 in Kentucky, Lynn Stanton Banks married Mary Rogers, (1833-1903). A physician and surgeon, Dr. Banks had an active practice in Marion County until his death on April 19, 1865. The Rogers family also immigrated to Missouri from Kentucky.
