# **Historical Note:**

Jabez Smith was born in Spotsylvania County, Virginia, on March 12, 1787, to George Smith and Beheathland Brent Dade Smith. He married Susan Royster in 1827. She died in 1844, and he married Ann Eliza Hennin in 1851. Smith was a wealthy landowner and he enslaved hundreds of individuals in his lifetime. He was also a land speculator who moved to Jackson County, Missouri, in 1843. He died in 1855.
