The records of the Young Store contain daybooks, cashbooks, and ledgers from a store in Oregon County, MO. No information is available on the establishment or dissolution of store.

DONOR INFORMATION

The records were donated to the University of Missouri by Robert Gordon Young on 19 November 1963 (Accession No. 3554).

SCOPE AND CONTENT NOTE

These records offer a glimpse into the workings of a small-town general store, which survived the transition from the nineteenth to the twentieth century. They indicate what types of items were stocked, the price range, and which items were most in demand.
