Four diaries written by a Macon County, Missouri, farmer. His daily entries, spanning almost fifteen years, describe farm life, livestock breeding, social activities, transportation, illness, death, and daily changes in the wind and weather. Also detailed personal and business expenses.

SCOPE AND CONTENT NOTE

These diaries give a comprehensive view of life on a Missouri farm during the late 1800s. The author had a wife, two married daughters, and several grandchildren. Thrasher itemized his daily expenses including numerous loans and other financial transactions with family, neighbors, local merchants, livestock traders, and farm laborers, and his daily household and farm expenses. He also described his many building and construction activities, house remodeling and redecorating, and weekly trips to Clarence. Thrasher recorded most of his social interactions--visiting friends and neighbors whenever they were sick, Sunday dinners, holiday gatherings, church services and meetings, and the tragedies and comedies of his existence. He was an astute observer and commentator. Some pages in each volume have been filmed twice, and other pages omitted.
