Historical Note:

Henry E. Parberry enlisted in the Confederacy as a private in Springfield, Missouri, on January 15, 1862. He was captured in 1853 and remained in prison until 1865. James Parberry, presumably his father, was an enslaver from Franklin County, Virginia, who purchased an enslaved woman named Martha and her child from Thomas Lunkin for \$400 on February 4, 1829.

Scope and Content Note:

The collection includes copies of the receipt for the sale of Martha and her child; Civil War letters concerning conditions in prison camps in New York and Maryland; and other miscellaneous letters and letter fragments.
