Biographical Note:

James A. Price was born on September 7, 1829, to Nathaniel H. and Ann (Lee) Price. He was first married to Russella (Warner) Price and they had four children together. Russella died in 1875. James married Martha Adelia (Gibson) Price in 1880. James served as a captain, major, and colonel for the Union Army during the American Civil War. He died on August 17, 1916.
