# **Historical Note:**

On January 16, 1960, a group of MU alumni and friends met for lunch in the Student Union of the University of Missouri-Columbia with Dr. Ralph Parker, Dr. Lewis Atherton, Dean Joe Covington, Dr. Homer Thomas, and Bertis Westfall. In conjunction with the State Historical Society of Missouri, they resolved to organize a group called "Friends of the University of Missouri Library." Within five months, the group had received donations of books and manuscripts from twenty-six benefactors as well as cash gifts of more than \$1,000.00. Today, the Friends group is an association of donors dedicated to developing private support for the MU Libraries.

### Arrangement:

The collection has been arranged alphabetically by type of material.

### Scope and Content Note:

The collection contains materials related to the operations of the Friends of the University of Missouri Library, including constitutions, membership documents, reports, election materials, correspondence, programs, meeting minutes, newsletters, and news clippings.
