**Abstract:** Personal memorabilia of Grace Price Paxton, including programs from Christian College, school certificates; correspondence, diplomas, and legal documents concerning the Price and Holliday families; 1872 land deeds for and in Caldwell County, Missouri, sold by the Hannibal and St. Joseph Railroad; bill of sale for an enslaved woman, Silvy, and her child; and World War II ration books.

Grace E. (Price) Paxton was born on October 7, 1880, to Robert and Elizabeth (Holliday) Price. She was married to Richard Gentry Paxton and they had one child, Richard Gentry Paxton, Jr. Grace died on February 15, 1976, and her husband, Richard, died on October 8, 1950.

## Correspondence

This series contains correspondence to and from the Price and Holliday families, 1846-1898, n.d. The letters discuss elections, family matters, and schooling. The series is arranged chronologically.

#### **Family Papers**

This series contains land deeds, court records, and miscellaneous financial papers of the Price and Holliday families. Included in this series are war ration books and a booklet on politics, produced by the Ligget and Myers Tobacco Company, 1912. Of note in this series is a bill of sale for an enslaved woman, Silvy, and her 18-month-old child, who were purchased by Junius A. Holliday in 1853.

### **Education**

This series contains certificates and diplomas awarded to Robert B. Price and Grace Price, commencement and alumni booklets, and miscellaneous material on the Christian College in Columbia, Missouri.

#### **Oversize**

This series contains a diploma awarded to Grace Carle Price, from Christian College, Columbia, Missouri, 1899. Also included are two diplomas earned by Richard Gentry Paxton, from the University Senior High School and the Columbia Public Schools.
