Manuscript copies of historian and educator Lyle Dorsett's books, working drafts as well as final drafts, and articles, both published and unpublished, relating to the Pendergast political machine and other Kansas City topics. Also research note cards and notes.

BIOGRAPHY:

Lyle Wesley Dorsett was born in Kansas City, Missouri on April 17, 1938. He received B.A. and M.A. degrees from the University of Kansas City in 1960 and 1962 respectively. He received a Ph.D. in History from the University of Missouri-Columbia in 1965. While a graduate student, Dorsett was associated with the Kansas City History Project.

After receiving his doctorate, Dorsett joined the faculty at the University of Missouri-Saint Louis. He later taught at the University of Southern California and the University of Colorado before joining the faculty at the University of Denver in 1972 as a professorship in history.

Dorsett's publications include: *The Pendergast Machine*, 1968; *The Queen City: A History of Denver*, 1977; *Franklin D. Roosevelt and the City Bosses*, 1977; and, with A. Theodore Brown, *KC: A History of Kansas City, Missouri*, 1978.

DESCRIPTION:
