The collection consists of administrative records, board meeting minutes, legislation at the federal and state levels, community contact and involvement, funding, and programs related to ReDiscover Mental Health Services and its predecessor, Community Mental Health Center-South.

ReDiscover is a nonprofit community mental health agency that offers a full spectrum of programs and services for people whose lives have been affected by serious mental illness or substance abuse. The organization was founded by a group of volunteers in Lee's Summit, Missouri, and was incorporated in 1969. The organization has gone by several names, including Research Mental Health, North Star, and Common Ground. It took on the name ReDiscover in 2003.

The records were donated to the University of Missouri by the Community Mental Health Center-South on April 24, 1981 (Accession No. KA0088).
