The collection consists of the personal papers of Frank E. Brennan, a civic leader and former city council member of Kansas City, Missouri.

Frank E. Brennan was born in St. Louis, Missouri, in 1922. He served in the United States Army Air Forces during World War II and the United States Air Force in the Korean War. Brennan earned a bachelor's degree, and later a law degree, from St. Louis University. He moved to Kansas City, Missouri, in 1958 and worked as an agent for the New England Life Insurance Company. In 1982, he established the Brennan Marketing Group, which served as a consulting firm in Greater Kansas City. Between 1967 and 1971, he served on the city council. During the 1968 Kansas City race riots, he spent several days on Kansas City's eastside seeking to alleviate racial tensions. Brennan was a member of the American Bar Association and the Kansas City Metropolitan Bar Association. He served as a board member for the Chamber of Commerce of Greater Kansas City, was a director for the Centurions Leadership Training Program, and was a trustee for the National Association of Life Underwriters. He died in February 1994 and is buried at Calvary Cemetery and Mausoleum in St. Louis, Missouri.
