The collection consists of the personal and business papers of Carl DiCapo, a prominent businessman and civic leader in Kansas City, Missouri. Materials include DiCapo's civic, cultural, and community activities, photographs, video tapes, certificates, plaques, and items related to the Italian Gardens Restaurant.

Carl J. DiCapo was born on November 7, 1927, in Kansas City, Missouri. He attended Northeast High School, Kansas City Junior College, and the University of Missouri, where in 1991 he received his degree in Hotel and Restaurant Management. An employee of Italian Gardens Restaurant since 1953, DiCapo became the president in 1976 and served in that capacity until his retirement in the late 1990s. He was active numerous civic organizations within the Kansas City metropolitan area. He served as the director of the Missouri Restaurant Association in 1972, the director of the Don Bosco Community Center in 1971, president of the Ethnic Enrichment Commission in 1980, commissioner of the Kansas City Board of Parks and Recreation in 1986, a member of the Desegregation Monitoring Committee in 987, and as chairman of the Citizen's Association. DiCapo holds memberships in the Boy Scouts of America, UNICO, Lambda Chi Alpha fraternity, and the Friends of the Zoo.
