Historical Note:

During World War II, the United States enacted the Selective Training and Service Act of 1940. Beginning September 16, 1940, all men between ages 21 and 45 were required to register for the draft. Individuals underwent physical examinations by physicians and dentists to determine mental and physical fitness for military service. Men selected from the draft lottery served a mandatory one-year sentence in the armed forces.
