Historical Note:

Sainte Genevieve, Missouri was founded in the 1730s-1740s, by French Canadians and migrants from Illinois. The oldest permanent settlement in Missouri, its early settlers were drawn to the area for the salt springs, desirable farmland, and proximity to the Mississippi River.

Arrangement:

The collection has been arranged in its original order by volume.

Scope and Content Note:

The collection contains two volumes with the civil and criminal ordinances for the city of Sainte Genevieve, Missouri. Volume 1 consists of ordinances 1 through 122 dating from May 1849 to September 1862. A subject index precedes the ordinances. Volume 2 contains ordinances 123 through 397 and is dated January 1863 to December 1895. The ordinances deal with a variety of civil and criminal matters. They include specific penalties and fines established for unlawful actions and ordinances authorizing payments for various financial obligations.
