Historical Note:

The Shannondale enterprise was initiated on November 4, 1929, as a result of mission work begun earlier by Reverend Paul A. Wobus and local evangelist, Zenith 'Zene' Yount. Supported by the Board of Missions on the Evangelical and Reformed Church, Shannondale was to be a nonsectarian community church for the area. The program was expanded in the summer of 1931, with the arrival of Vincent W. Bucher, a student of theology at Heidelberg College in Tiffin, Ohio. Bucher returned with his wife and son in 1934, to begin a thirty-three year career as resident pastor at Shannondale. The Buchers left Shannondale in 1967, and moved to Getzville, New York.

Arrangement:

The collection has been arranged in its original order by volume.

Scope and Content Note:

The collection contains copies of nine scrapbooks with printed material, letters, and photographs from the Shannondale Community Church-Center in Shannon County, Missouri. The materials detail the establishment of Shannondale and of various religions and social projects. Reverend Bucher compiled seven of the nine scrapbooks in the collection. Volumes 8 and 9 were compiled by Grace May Baldwin of Florissant, Missouri. Reverend Bucher and Mrs. Baldwin identified and dated the materials wherever possible and have provided typewritten commentaries in some instances. The scrapbooks contain many photographs of the upper Current River and Shannon County area, and many of the residents of the region are profiled.
