Historical Note:

Mine La Motte, a town in Madison County, Missouri, prospered in the late nineteenth and early twentieth century. Settled in 1717, by the French and their slaves, the town was immediately the site of lead mining. The first mine in Missouri, operations continued through the twentieth century with numerous companies operating in the area during its history.

Arrangement:

The collection has been arranged in its original order in one folder.

Scope and Content Note:

The collection contains a photocopy of a typescript compilation of the abstract of title to the property at Mine La Motte in Madison County, Missouri. The abstract was excerpted from the official records of Madison County from the early 1800s through 1922. The compiler and date of compilation are unknown, although the last transaction listed occurred in 1922.
