Biographical Note:

John Compton Brickey Jr. was born in Potosi, Missouri, in 1814, where his father was a merchant and county clerk. The younger Brickey left Potosi about 1835, to take a position with the business house of J.M. White at Selma, Missouri, a commercial landing on the Mississippi River. He moved to the landing that would bear the family name in 1837, where he established a general store and an adjacent woodlot. His business drew customers from the local area and from steamboats on the river. With the exception of two years in the California gold fields, Brickey remained in business at the landing until his retirement in 1890. He moved to Festus, Missouri, where he died in 1903.

Arrangement:

The collection has been arranged in its original order.

Scope and Content Note:

The collection contains a microfilm copy of an account ledger for a general merchandise operation at Brickey's Landing on the Mississippi River in Sainte Genevieve, Missouri. John Compton Brickey Jr. operated the business. The ledger from Brickey's Landing is a standard listing if individual accounts, probably entered from the store's daybooks. The accounts are grouped in two independent sections, each numbered separately. The first section contains accounts for 1837-1842, and the second section includes accounts for 1842-1843. Indexes for each section are at the front of the volume.
