Phelps County, Missouri was organized in 1857. The county seat, Rolla was organized in 1858 and made the county seat in 1861. The first county court assembled in the John Dillon cabin. Booker H. Rucker, born August 4, 1868 in Audrain County, Missouri served as the county clerk of Phelps County in the early 1900s.
