**Abstract:** The John J. Watts Papers are notebooks of genealogical records kept by a circuitriding Baptist minister in the northern Ozarks. The records cover Phelps, Pulaski, Texas, and parts of Maries, and Dent counties in south-central Missouri.

#### **Historical Note:**

John Jones Watts was born in 1839 in Warren, Maine, where he became a member of the Warren Baptist Church in 1858. He moved to Missouri sometime after the Civil War, and married Jane Woolsey of Rolla in 1872. He began preaching the gospel in 1877, and was ordained a minister at the Beaver Creek Baptist Church in 1879. Watts maintained close ties with the congregation at Beaver Creek, but traveled extensively throughout Phelps, Pulaski, and Maries Counties preaching at baptisms, marriages, funerals, and organizational meetings for local churches. He was an avid genealogist, and as a circuit-riding preacher had the opportunity to gather family information from a wide geographical area. His record keeping may have begun while he was still in Maine.

#### **Scope and Content Note:**

#### Genealogy

This series contains the records written by John J. Watts on births, marriages, deaths, school and church attendance from the counties he visited during his work as a preacher. Most of the volumes are organized by families and geographical areas. Volume 1 is an index created most likely by John Watts' oldest son, Zina Emerson Watts. The name index covers volumes 2-10. Volume 11 has a separate index inside the front cover. In Volume 13 the 'Steward Record' was enclosed inside the Logan Family book and filmed together. Volumes 14-16 have page numbers that run consecutively throughout them. Volume 18 includes information on individuals in the community of Beulah in southern Phelps County. Volume 19 includes miscellaneous notes written on scraps of paper that were arranged alphabetically and then filmed. Watts recopied most of these notes into his notebooks; there are numbers on those pages indicating the volume and page number. Volume 20 indexes marriages recorded in Volume 24. Volume 21 contains the marriages performed by Watts from November 11, 1877, to April 28, 1898. There is an index at the back of Volume 25 and most of the death record entries are from Warren, Maine. Volumes 26-27 have indexes inside the front cover. The Phillips family record was enclosed inside Volume 28 and filmed together.

#### Personal

This series includes the personal records related to John J. Watts work as a circuit-riding preacher. These records include miles travelled, services, such as weddings, funerals, and church

services performed, and his own personal finances. Volume 36 includes entries related to funerals he attended or officiated at and the records of surnames go through the letter "M."
