Historical Note:

Campbell Camp No. 488 was organized at Springfield, Missouri on March 6, 1894. Members consisted of individuals who served in the Confederate Army during the Civil War. The group addressed topics such as maintenance of the Confederate cemetery at Springfield and the erection of a suitable monument there, and the observance of Memorial Day. The local chapters of the Sons of Confederate Veterans and the United Daughters of the Confederacy often cooperated with the Campbell Camp in these endeavors.

Arrangement:

The collection has been arranged in its original order.

Scope and Content Note:

The collection contains a microfilm copy of a volume with the records of the United Confederate Veterans, Campbell Camp No. 488 in Springfield, Missouri. The volume includes the constitution and bylaws, minutes of meetings, lists of the members, and miscellaneous papers. Tipped in at the end of the volume are miscellaneous papers dating to May 1915. They include eulogies for deceased comrades and papers concerning state pensions for Confederate veterans. A list of selected contents has been filmed at the front of the volume.
