Abstract: The Grand Army of the Republic, Lutesville, Missouri Records contain record books and miscellaneous papers of the Grand Army of the Republic Franklin Shanks Post No. 100 in Lutesville, Missouri. The volumes include meeting minutes, treasurer's report, communications addressed to the post, and a history of the Grand Army of the Republic.

Historical Note:

The Grand Army of the Republic was a national association of Union Civil War veterans. The Lutesville chapter organized on August 4, 1883. A. R. Jacques served as the first post commander. The posts were interested in marking and maintaining veteran graves and dealing with veteran's receiving pensions.

Scope and Content Note:

Volumes

This series contains a record and order book of the Grand Army of the Republic Franklin Shanks Post No. 100 in Lutesville, Missouri. The volume includes meeting minutes, treasurer's report, and communications addressed to the post. The volume also includes information on membership recruitment, payment of dues, and discussion on the group's activities. The last meeting in the volume was on July 10, 1889.

Volume 2 contains an address by Reverend Jeffrey Jackson regarding the history of the Grand Army of the Republic. The volume was also used by Lawrence Lee Hahn of Marble Hill, Missouri as a school notebook and contains several history and math lessons. He was the husband of Mary L. Hahn. The series is arranged in chronological order.

Records

This series consists of meeting minutes, addresses, correspondence, newspaper articles, list of soldiers, and GAR papers of the Lutesville post. Many of these records are copies and typescripts with some original records dating from 1883 to 1904. Copies of the original post members from 1883 is also included. The series is arranged in chronological order.
