Biographical Note:

Sarah Ann Reed was born on December 2, 1886, to George W. and Sarah E. Reed in Beulah, Phelps County, Missouri. She married Elmer V. Sturgeon on August 30, 1906. Together they had one daughter, Geraldine, who only lived a few days. Elmer died in March 1943. Sarah then married Lucien Virgil DeForest of Licking, Texas County, Missouri, in September 1944, in Arkansas. Sarah was living in Rolla, Missouri at the time. She died on November 10, 1965, in Texas County and was buried next to her first husband in the Beulah Cemetery in Phelps County, Missouri.

The collection contains photocopies of a scrapbook of genealogical information on residents of Phelps and Texas Counties in Missouri collected by DeForest.
