Historical Note:

The Joplin Railroad was incorporated in 1875, by miners and businessmen in Jasper County, Missouri, after eastern investors declined the opportunity to build the line. Leonidas P. Cunningham, one of the earliest miners in the area, led the effort. Construction began in 1876, and the rails reached Girard, Kansas, via Pittsburg, in 1877. Although the completed line had only thirty-eight miles of track, it immediately became the object of attention of two much larger roads. The Kansas City, Fort Scott, and Gulf Railroad south the South Joplin Railroad as a link to Springfield, Missouri, and then to Memphis, Tennessee. The St. Louis and San Francisco Railway wanted the Joplin line's access into the mineral district of Missouri and Kansas, and also wanted to forestall any competition from the Kansas City, Fort Scott, and Gulf. The St. Louis and San Francisco leased the line, and then purchased it in 1879 for \$300,000.

Arrangement:

The collection has been arranged in its original order.

Scope and Content Note:

The collection contains a microfilm copy of a construction ledger for the Joplin Railroad Company. The ledger contains entries for purchases made by the company.
