Abstract: The William B. Williams Records contains a microfilm copy of an account ledger for Dr. William B. Williams, a physician in Farmington, Missouri. The entries include the names of patients, the nature of services rendered, and payments received in cash and kind.

Biographical Note:

William B. Williams was born on August 18, 1813, in Connecticut. He and married Mary H. Cole in Washington County, Missouri, on September 1, 1840. Together they had eleven children. By 1860, the family was in Saint Francois County, Missouri, where Williams worked as a physician. He died on July 2, 1893, and was buried in the Murphy Cemetery in Saint Francois County.

Arrangement:

The collection has been arranged in its original order.

Scope and Content Note:

The collection contains an indexed ledger documenting the medical services rendered by Dr. William B. Williams. Most of the patients were residents of Saint Francois County, Missouri, but a few individuals from Sainte Genevieve and Jefferson counties were also noted. Families are indexed by the name of the head of the household and each entry indicates which family member was treated. The notations for each visit are followed by charges for services, and any payments in kind, and, in those case, the goods and services received in lieu of cash are mentioned.
