Abstract: The Frederick August Kullman Papers contain photocopies of the miscellaneous papers and Civil War diary of Frederick A. Kullman, a resident of Cole Camp, Benton County, Missouri, and a soldier in the 13th Missouri Cavalry. His papers include confirmation and emigration certificates from Bavaria, military service records, correspondence, photographs, and genealogical information on the Kullman family. The wartime diary covers service at Rolla and Licking, Missouri in 1865.

Biographical Note:

Frederick A. Kullman was born in 1843, in Schwarzburg-Sonderhausen, Prussia (now in Germany). His family emigrated to the United States in 1855, settling in Benton County, Missouri. Kullman was one of the first Union volunteers from Benton County during the Civil War. He served from June 1861 through May 1866, first in the Benton County Battalion, then the 5th Missouri State Militia Cavalry, and finally in the 13th Missouri Cavalry, a unit composed of veteran militia cavalrymen. Kullman returned to Benton County in 1866, where he married Margaretha Barbara Hassfurther, an immigrant from Bavaria. The Kullmans lived in Benton County until their deaths, his in 1893 and hers in 1927.

Scope and Content Note:

Personal Papers

This series contains the personal papers of Frederick A. Kullman. Most of the papers are related to his military service, but two prewar items include his certificate of confirmation in Prussia and a certificate of approval for the Hassfuther family to emigrate from Bavaria in 1856. His military papers include his discharge papers, his appointment as eighth corporal of the 5th Missouri State Militia Cavalry, and pension papers filed by his widow after his death. Also related to his military service are letters to his father, written from Salem and St. Louis, Missouri. Several items are written in German, typed translations are available. There is also a photograph of Frederick and Ernest John Kullman in folder two. The earliest papers show Kullman's name as Friedrich A. Kullman and then slowly Anglicizes to Frederick. This series is arranged chronologically.

Diary

This series consists of a diary written by Frederick A. Kullman. The diary covers the period from January 1 through April 26, 1865, during which Kullman served at posts in Rolla and Licking, and received his veteran's furlough. This series is arranged chronologically.
