Biographical Note:

Willis Allen Spiller was born in January 1834, in Illinois. He married Nancy Katherine Stinson in 1855, and together they had thirteen children, eleven of whom survived to adulthood. Spiller served with the 110th Illinois Infantry Regiment during the Civil War. Spiller and family came to Lebanon, Laclede County, Missouri in 1870, from Carbondale, Illinois. He worked as a merchant in the rapidly growing town for many years. Spiller died in Lebanon on November 14, 1913.
