Abstract: The B. F. Carney Papers contain a Carney dollar promissory note issued by B. F. Carney at Crane, Missouri. Carney issued one thousand of the notes to prove a Great Depressionera theory of money. Also included, are a photocopy of a letter written by Carney's son in 1969 explaining the history of the notes and an audio cassette with transcript containing Ben Carney Jr.'s explanation of the B. F. Carney dollar.

Biographical Note:

B. F. Carney was born on November 8, 1878, in Barry County, Missouri. He married Effie May Campbell in March 1899 and together they had one child, Gladys I. Effie died in June 1904. He remarried a few years later to Cordye Elizabeth and together they had three children; Carrie Pearl, Lynn D., and Benjamin F. Cordye died on September 6, 1947.

Carney created the 'Carney dollar' promissory note to prove his belief that currency was given its value by peoples' belief in the government meeting its obligation. Carney believed that the community of Crane, Missouri, would believe in his backing of the 'Carney dollar' and would use it as currency. Starting in February 1932, Carney began to print and circulate his 'dollar' in the community. The community members used the notes as regular currency and after proving his theory Carney recalled the notes, but only recouped half of them, as the rest were kept, mostly as souvenirs.

B. F. Carney died May 18, 1937, and his son kept the promise of redeeming any note discovered in keeping with his father's wishes. Ben F. Carney Jr. was born September 30, 1915, and lived in Crane, Missouri until his death on October 10, 2003.
