**Abstract:** The Eugene Pernot Medical Records contain a microfilm copy of a daybook of a physician at Sainte Genevieve, Missouri. The daily entries list the patients treated and medicines prescribed from July 1848 through December 1853.

**Biographical Note:**

Eugene Pernot was born in 1817 in France. He and his wife Louisa were in Illinois by 1837 and in Missouri by 1844. Together they had three children, Carolina, Henri, and Joseph Emilie. Pernot is included on an undated list by the sheriff of Sainte Genevieve County as one of six physicians in the county. He worked as a physician in Sainte Genevieve from at least 1848 to 1860.

**Arrangement:**

The collection has been arranged in its original order.

**Scope and Content Note:**

This collection contains a daybook with records of Dr. Eugene Pernot. Pernot, a physician in Sainte Genevieve, Missouri had a practice that mostly consisted of bleedings and blistering. Judging from his record book, Pernot relied heavily upon mustard plasters. He also prescribed from the standard nineteenth-century pharmacopeia available to him. Excepting occasional cases of accidental injury and childbirth the nature of the patient's complaint was not recorded.
