Historical Note:

The United Daughters of the Confederacy was founded in 1894 in Tennessee. It was the outgrowth of numerous local ladies' organizations and two state organizations: the Daughters of Confederacy in Missouri and the Ladies Auxiliary of the Confederate Soldier's Home in Tennessee. The United Daughters of the Confederacy, Missouri Division, evolved in 1890 from the support of Missouri women for the Ex-Confederate Association of Missouri in their efforts to build and furnish a home near Higginsville for disabled Missouri Confederate veterans. The name Daughters of the Confederacy (D.O.C.) was coined by Mrs. A. C. Cassidy of St. Louis. From marking soldiers' graves to creating educational, benevolent, patriotic, and historical programs, the society has rendered service to the South and the memory of Confederate soldiers, veterans, and their families.

Arrangement:

The collection has been arranged in its original order.

Scope and Content Note:

The collection contains a photocopy of a registrar's book for the Kate K. Salmon Chapter No. 631 from 1917. The volume contains membership records for the chapter. The book includes information on kinship with Civil War veterans, and a list of Confederate dead buried at Englewood Cemetery in Clinton, Missouri.
