The Cave Spring Association of the Freewill Baptist Churches organized in 1880. It was composed of thirteen churches, mostly in Oregon County, Missouri. At least one church, Mill Creek Church, was located in Ripley County, Missouri and the Pleasant Valley Church was located in Mammoth Spring, Arkansas.

Scope and Content Note:

The collection contains the minutes of the forty-second annual session of the Cave Spring Association of the Freewill Baptist Churches. It includes meeting minutes, articles of faith, covenant, and membership data for the constituent churches.
