The records, dating from 1903 to 1919 contain meeting minutes, membership and visitor rosters, and other organizational records.

#### **Historical Note:**

The United Confederate Veterans was organized on June 10, 1889 and headquartered in New Orleans, Louisiana. The group was an American Civil War veterans' organization consisting of several state level groups that merged. The Campbell Camp No. 488 at Springfield, Missouri was organized on March 6, 1894. The group addressed topics such as maintenance of the Confederate cemetery at Springfield and the erection of a suitable monument there, and the observance of Memorial Day. A statewide reunion of Confederate veterans was held in Springfield in 1915.

### **Arrangement:**

The collection has been arranged in its original order.

## **Scope and Content Note:**

The collection contains records of the Campbell Camp No. 488 located in Springfield, Missouri. The records include discussions of admittance of members to the Confederate Home at Higginsville, Missouri, and the relief of needy veterans, resolutions on the deaths of members of the camp, and documents regarding the controversial disbursement of funds collected to defray the expenses of the statewide reunion of the United Confederate Veterans held at Springfield in 1915.
