Phelps County, Missouri was established in 1857 and Rolla was designated the county seat in 1861. Edwin Long served as city mayor in 1913 and F. A. Germann served as city clerk.

**Arrangement:**

The collection has been arranged in its original order.

**Scope and Content Note:**

The collection contains a pamphlet with an itemized account of the financial affairs of Phelps County, Missouri. It was prepared by the county clerk, F.A. Germann and was published as a supplement to the *Rolla Herald* on April 9, 1914. The financial information includes sections on the expenses for the courthouse and jail, incidentals, stationary, the State Hospital for the Insane, criminal costs, salaries, paupers, elections, road and bridges, road districts, municipal funds, small pox, inquests, stenographers, vital statistics registration, expenditures, and recapitulation.
