### Biographical Note:

Alonzo V. "Lon" Hogan was born on January 11, 1883 to John S. and Martha *Lovan* Hogan on the family farm outside Willow Springs, Missouri. His parents sold the farm in 1897 and moved to Birch Tree, Missouri. He worked for the Cordz-Fisher Lumber Company until it closed. He then worked at the hub mill in Fishertown, a company town constructed by the Ozark Land and Lumber Company. Hogan also opened a restaurant and photography business in Fishertown. After the Ozark Land and Lumber Company closed its mill, Hogan moved to West Eminence and worked for the Missouri Lumber and Mining Company. Hogan married Alta V. Kofahl on December 27, 1906 and together they had four children. Hogan died in on September 10, 1981.

### Arrangement:

The collection has been arranged in its original order.

### Scope and Content Note:

The collection contains views of Shannon County, Missouri from the collection of Lon Hogan. Included are views of Eminence, Fishertown, and Winona showing church and school groups, a baseball team, a band, a store, and Hogan's Photo Gallery. There is also a view of the Willow Springs Bank at Willow Springs, Howell County, Missouri.
