The minutes include the constitution, articles of faith, rules of decorum, and membership statistics.

Historical Note:

The Union Association was formed in 1847 by churches along the Missouri-Arkansas border. By the time of its eighth annual meeting, it had added Predestinarian to its title. Elder J. M. Potter was chosen moderator of the meeting which included delegates from seven churches representing 123 members.

Arrangement:

The collection has been arranged in its original order.

Scope and Content Note:

The collection contains the eighth annual meeting minutes of the Union Association. The minutes include the constitution, articles of faith, rules of decorum, and membership statistics. John Brown, from the Little Piney Association of Regular Baptists attended the meeting as a representative of that association.
