These are municipal records of Farmington, St. Francois County, Missouri. Included are the charters of the city, ordinances, the records of the boards of aldermen and trustees, oaths of office, records of bonds and commissions, tax assessments, and a partial census of the city.

The collection consists primarily of the ordinances and regulations of the city as adopted by the town council, known later as the Board of Trustees and the Board of Aldermen. The records are complete for the period 14 November 1856 -- 7 January 1929. There are also volumes of tax assessments, 1876-1878, the oaths of city officials, 1884-1900, an enumeration of the citizens of Wards 1 and 2, 1901, and a record of bonds and commissions, 1901-1912. Indexes to the subject matter are contained in some of the volumes.
