Historical Note:

Thirteen freewill, or regular, Baptists met on November 1, 1869 to organize the Liberty Church. William H. Davis, Samuel Dennis, and John Hefton were chosen deacons, and Sanford Turner was appointed clerk. The minute book begins with the organizational meeting and continues through August 29, 1874. The minutes are generally brief and routine, but there are records of several individuals excluded from the church for fighting, stealing, and other unacceptable behavior.

Scope and Content Note:

These are minutes of meetings and a roster of members of the Liberty Freewill Baptist Church near Phillipsburg in Laclede County, Missouri. The minutes deal primarily with the admission and exclusion of members.
