Historical Note:

Henry Louis Rozier, son of Francis Claude Rozier and Zoe Valle, was born in Ste. Genevieve, Missouri, on June 3, 1849. He married, first, Mary Amanda Janis, and, after her death, second, Sallie Mary Carlisle. H. L. Rozier died in Ste. Genevieve on August 12, 1927.

A member of a prominent mercantile family in Ste. Genevieve, H. L. Rozier, in addition to other commercial activities, acted as a “private banker,” making loans to local firms and individuals. He also invested in several mining enterprises, including ventures in Arizona, California, and Colorado.

These are a ledger and journal of Henry Louis Rozier, a private banker in Sainte Genevieve, Missouri. Accounts indicate loans, payments, and other financial transactions.
