The partnership of Harris & Janis was a "banking house" in Ste. Genevieve, Missouri. The partners were Oliver D. Harris and Jules F. Janis, both of whom were experienced in the financial and commercial affairs of the town.

The records here are for the most part unembellished lists of financial transactions, and should be used in conjunction with previously cataloged records of the firm (WHMC-Rolla collections R006 and R434). Entries indicate that the Merchants' National Bank of St. Louis acted as the firm's central banker. Volumes 2 and 3, and the bundles, are stored in OVERSIZE.
