Historical Note:

The Community Chest was a volunteer organization that collected funds in Webb City for charitable and civic purposes. All proceeds collected during the annual fall fundraising drive were disbursed in the following year. Among the organizations that received money from the Community Chest were the Jasper County Welfare Association, the Salvation Army, the Boy Scouts of America, the Girl Scouts of America, the Webb City Parent Teacher Association, the Jasper County War Chest, and the Webb City Society for Crippled Children. The organization was disbanded in 1955.

Arrangement:

The collection has been arranged in its original order.

Scope and Content Note:

This collection consists of records of contributions, minutes of meetings, and miscellaneous papers of the Webb City Community Chest in Webb City, Jasper County, Missouri. The records begin with the names of contributors in 1939 and continue through the dissolution and final settlement of the Community Chest in 1955.
