Abstract: The Dixie School, Jasper County, Missouri Records contain a microfilm copy of the district clerk's record book for District No. 6 in Jasper County, Missouri. The record book includes minutes of the annual meetings, proceedings of the board of directors, annual enumeration of the district, lists of resident taxpayers, oaths of officers, estimates of school expenses, teachers' contracts, and records of expenses.

Historical Note:

School District No. 6 was created in 1886, from sections of districts 2 and 5. The District encompassed parts of Townships 29 and 30, Range 31 and 32 in northern Jasper County. The school, known as Dixie School, was first located four miles northeast of the town of Alba. In September 1886, a new schoolhouse was built one mile north of Alba.

Arrangement:

The collection has been arranged in its original order.

Scope and Content Note:

This collection contains one volume of district clerk records from Dixie School District No. 6 in Jasper County, Missouri. It includes annual meeting minutes, board of directors' proceedings, resident taxpayer lists, annual enumeration of the district, oaths of officers, school expense estimates, and expense records.
