### **Historical Note:**

Voters in Township 32 North, Range 12 West organized Texas County School District No. 2 on April 6, 1886. Hiram King was elected chairman of the new district, and K. R. Tracy was elected clerk. The district decided to situate Mill Creek School in Section 23, a few miles south of Plato, Missouri.

# **Scope and Content Note:**

# **District Clerk Records**

This series contains the clerks' records for the organized Texas County School District No. 2. The records include minutes of annual meetings and meetings of the board of directors, rules and regulations, teachers' contracts, estimates of school expenses, financial records, lists of taxpayers, enumeration of students, and oaths of directors. The records are complete for 1886 through 1925.

# Teachers' Registers

The teachers' registers include attendance records, term reports to the district clerk, records of visitors, and monthly summaries. The last two volumes follow the Welch System for standardized supervision and record keeping. There are chronological gaps in the records from 1897 to 1900, from 1907 to 1910, and from 1915 to 1921.
